#### **NEW BUSINESS**

The Board discussed changes to Statutes & Regulations with the following being suggested:

- KRS 409.416 no changes
- KRS 409.420
  - o change "persons" to "entities" in entire statute;
  - o (1)(a) 1. break it into 2 sections
- 201 KAR 47:010 -
  - Change person to entity
  - Move fees to last section
  - Section 4(2) insert a contiguous state which grants reciprocity to Kentucky licensees
  - o other licensing requirements from Section 2
  - Section 5 delete section about fee refunds
  - Section 6(2)9b) spell out OSHA and HIPPA
  - Section 7(9)(b) delete address
  - Section 9(1)(g) delete material
  - Section 10 add license and inspection fees, change duplicate license fee to \$25; change discipline
    history to license verification and charge \$10, delete everything else except mailing list; charge in state
    licensees \$350 for an inspection up front; and require out of state licensees to pay for the cost of the
    inspection with a \$350 up front payment and the balance due before licensing
  - Section 11 add on behalf of the board
- 201 KAR 47:030
  - Section 2(6)9a) change the number of members on the complaint committee to 2;

- Section 5(2) add "by" after approved
- Section 5(4) change "grated" to "granted"; add "in regard to this matter" after "complaint"
- Section 7 rearrange order to make more sense

- o change numbering for questions involving officers
- Fix misnumbering
- o Copy information from B on bottom of page 2 into C on bottom of page 2
- o Add information about inspection fee
